Park regulations

- Do not camp or make campfires except at designated sites.
- Do not drive off the tracks.
- Do not disturb wildlife by sounding motor horns.
- Do not drive in the park between 7:30pm and 6:30 am.
- Do not bring dogs or other pets into the park.
- Do not litter.
- Do not bring firearms or ammunition into the park.
- Do not pick flowers or destroy any vegetation.
- Do not exceed the speed limit of 40km per hour (25mph).
- Retain all official receipts for inspection.

Gorilla tracking rules

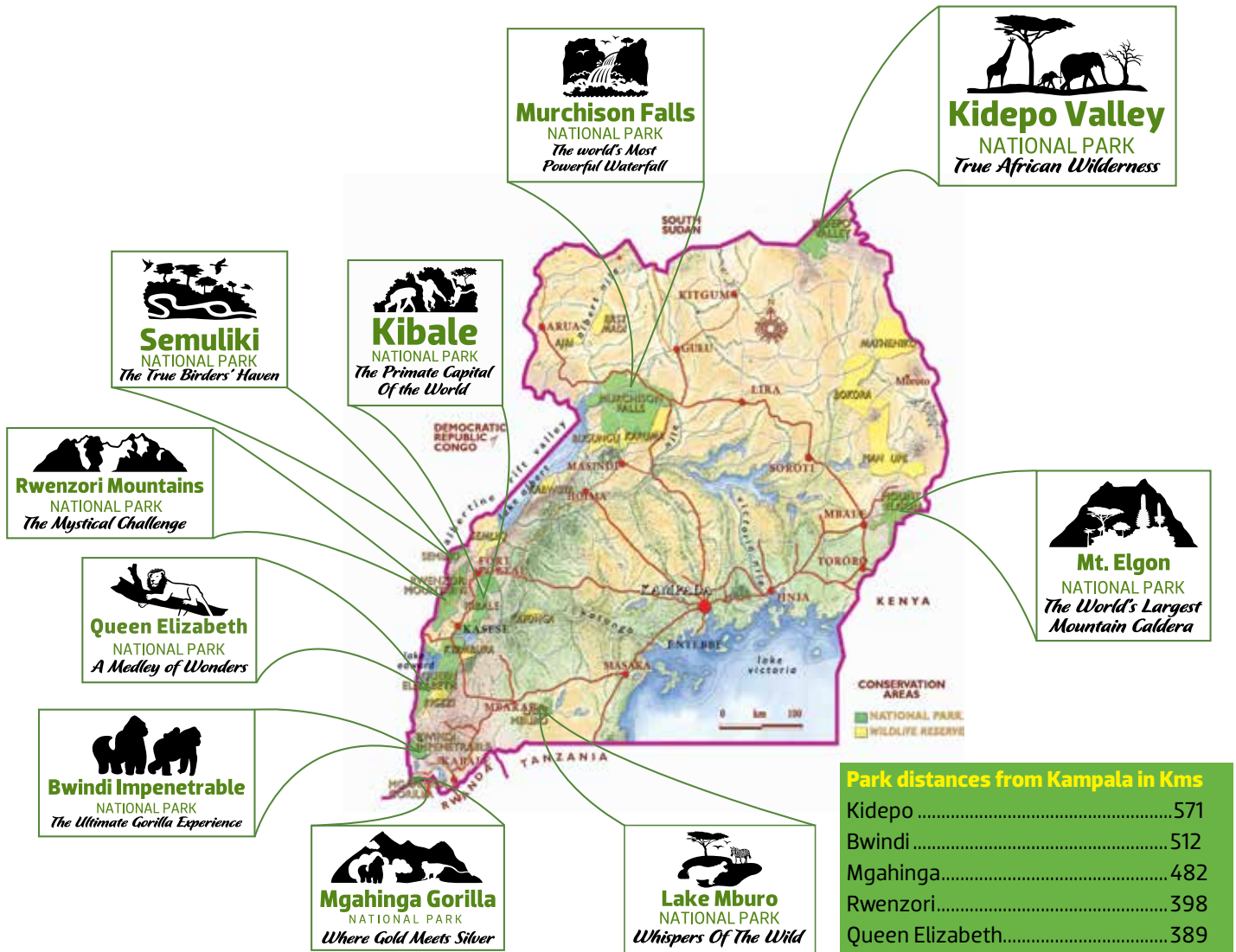
Before you set out:

- Do not visit the gorillas if you have a cold or other infectious illness.
- Human waste should be buried 30cm (12") deep
- Maximum number of visitors is eight persons per gorilla group

When you are with the gorillas:

- Maintain a 7m (21ft) distance from the gorilla
- Smoking, eating and drinking are not permitted on the tour
- If you must sneeze or cough cover your face and turn away from the gorillas, as they can catch coughs and colds from humans
- Visits are limited to one hour per gorilla group per day
- Do not use flash photography.

- Gorilla filming: US\$ 4,200 per hour while with the gorillas, Excludes Gorilla permits
- Chimpanzee: US\$ 1,050 per day includes entry fees, excludes chimp permits

For all filming activities:

- A 5% monitoring fee is included

RESEARCHER'S ACCOMMODATION

- Camping : UGX 100,000 per month for a group of up to ten individuals. Extra persons will be charged UGX 50,000 per month.
- Protected Areas with Vacant Staff Houses will be rented at UGX 100,000 per Person per month for East African Researchers and US\$ 100 per room per month by Non East African Researchers.
- Water and electricity will be paid separately

SPECIMEN COLLECTION

Whole Specimen (fauna)

- Application fee US\$ 100 each time a researcher applies for an export permit
- Value of medium large mammal species, bird species and crocodiles at the existing rate
- Smaller mammals US\$ 30 per animal
- Reptiles US\$ 30 per reptile
- Fish US\$ 2 per fish
- Insects US\$ 0.5 per insect
- Amphibians US\$ 1 per individual

Derivatives (e.g. dung, skin samples, blood samples, plant samples)

- Permit application fee of US\$ 50 each time a researcher applies for an export permit
- Specimen collection fee of US\$ 50 per Kg or less
- Liquid samples for US\$ 50 per litre or less

Chimpanzee tracking rules

For your own safety and the protection of the Chimpanzees, you are required to follow a few rules along the forest trails.

- Chimpanzees can catch your diseases, you must not enter the forest if you are sick.
- Do not leave litter in the forest
- If you need to urinate or defecate, do so off the trail. Bury your waste in a hole (30 cm deep) along with any toilet paper.
- keep as quite as possible in the forest, you will see more.
- Keep at least 8 meters (25 feet) from the chimpanzees at all times.
- Do not mimic Chimpanzees' vocalisation (you do not know what you might be saying!)
- Do not eat near the Chimpanzees.
- Do not chase the Chimpanzees
- Do not use flash photography.
